

#### SURVEYOR'S CERTIFICATE

I, ROBERT E. SAYERS, SURVEYOR, CERTIFY THAT I HAVE SURVEYED, DIVIDED, AND MAPPED THE LAND SHOWN ON THIS PLAT, DESCRIBED AS FOLLOWS: TIMBERLY NO. 3, A SUBDIVISION SITUATED IN THE NORTHWEST 1/4 OF SECTION 30, TOWN 7 SOUTH, RANGE 9 WEST, BURR OAK TOWNSHIP, ST. JOSEPH COUNTY, MICHIGAN, IS DESCRIBED AS FOLLOWS: COMMENCING AT THE NW CORNER OF SAID SECTION 30 AND RUNNING THENCE S 00°09'10 E, ALONG THE RANGE LINE, 1524.12 FEET TO THE NW CORNER OF THE PLAT OF TIMBERLY, SAID PLAT BEING RECORDED IN LIBER 5 OF PLATS ON PAGE 61, THENCE S 89° 45' 10" E, ALONG THE NORTH LINE OF SAID PLAT, 223.00 FEET TO THE NE CORNER THEREOF WHICH IS THE POINT OF BEGINNING OF THIS DESCRIPTION; THE BOUN -DARY RUNS THENCE S 00 09 10" E, ALONG THE EAST LINE OF SAID TIMBERLY SUBDIVISION, 735.00 FEET TO THE NW CORNER OF LOT 23 OF TIMBERLY NO. 2, SAID PLAT BEING RECORDED IN LIBER 6 OF PLATS ON PAGES 14 6 15, THENCE, FOLLOWING SAID PLAT OF TIMBERLY NO.2, N 89°50°50" E 225.00 FEET, THENCE S 00°09'10" E 98.05 FEET TO THE P.C. OF A 30 FOOT RADIUS CURVE TO THE RIGHT, THENCE SOUTHWESTERLY ALONG SAID CURVE AN ARC DISTANCE QF 47.10 FEET TO THE P.T. OF SAID CURVE (SAID CURVE BEING SUBTENDED BY A CHORD BEARING \$ 45°11'18" W 42.68 FEET), THENCE \$ 89°28'13" E 126.00 FEET TO THE P.C. OF A 30 FOOT RADIUS CURVE HEADED BACKWARDS TO THE RIGHT, THENCE NORTHWESTERLY ALONG SAID CURVE AN ARC DISTANCE OF 46.77 FEET TO THE P.T. OF SAID CURVE (SAID CURVE BEING SUBTENDED BY A CHORD BEARING N 44°42'48" W 42.17 FEET), THENCE N 00°09'10" W 170.36 FEET, THENCE N 89°50'50" E 400.00 FEET, THENCE S 00°09'10" E 174.40 FEET TO THE P.C. OF A 30 FOOT RADIUS CURVE TO THE RIGHT, THENCE SOUTHWESTERLY ALONG SAID CURVE AN ARC DISTANCE OF 47.18 FEET TO THE P.T. OF SAID CURVE (SAID CURVE BEING SUBTENDED BY A CHORD BEARING S 45°11'18" W 42.68 FEET), THENCE S 89°28'13" E 139.33 FEET TO THE MOST EASTERLY LINE OF SAID PLAT OF TIMBERLY NO. 2, THENCE S 89°28'13" E 157.04 FEET, THENCE N 00°09'10" W 437.93 FEET, THENCE N 32°30' E 95.88 FEET, THENCE N 57°30' W 189.30 FEET, THENCE N 32°30' E 66.00 FEET, THENCE N 57°30' W 126.00 FEET TO THE P.C. OF A 31.53 FOOT RADIUS CURVE TO THE LEFT, THENCE SOUTHEASTERLY ALONG SAID CURVE AN ARC DISTANCE OF 47.82. FEET TO THE P.T. OF SAID CURVE (SAID CURVE BEING SUBTENDED BY A CHORD BEARING S 52\*57'05"E 43.37 FEET), THENCE S 80°30° W 125.72 FEET TO THE P.C. OF A 31.59 FOOT RADIUS CURVE HEADED BACKWARD TO THE LEFT, THENCE NORTHWESTERLY ALONG SAID CURVE AN ARC DISTANCE OF 47.84 FEETATHE P.T. OF SAID CURVE (SAID CURVE BEING SUBTENDED BY A CHORD BEARING N 33°53'30" E 43.40 FEET), THENCE N 09°30' W 120.14 FEET, THENCE S 80°30' W 373.03
FEET, THENCE S 00°14'50" W 35.28 FEET, THENCE N 89°45'10" W 55.12 FEET TO THE
