OF A 1194.10 FOOT RADIUS CURVE TO THE RIGHT, THENCE SOUTHWESTERLY ALONG SAID CURVE WHICH HAS AN " I " ANGLE OF 10°08' 211.19 FEET (SAID CURVE BEING SUBTENDED BY A CHORD BEARING S 46°50' W 210.91 FEET) TO THE P.T. OF SAID CURVE.
