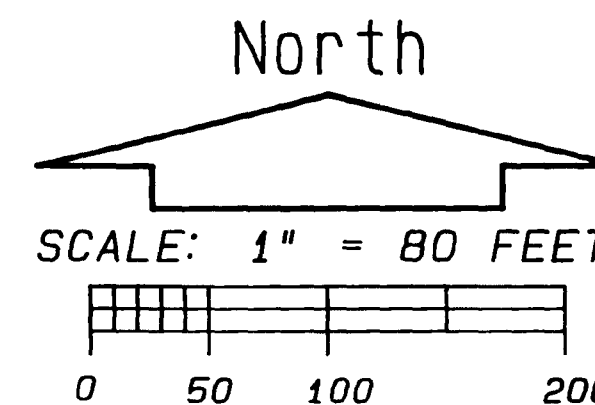


MAPLEWOOD SHORES NO. 2

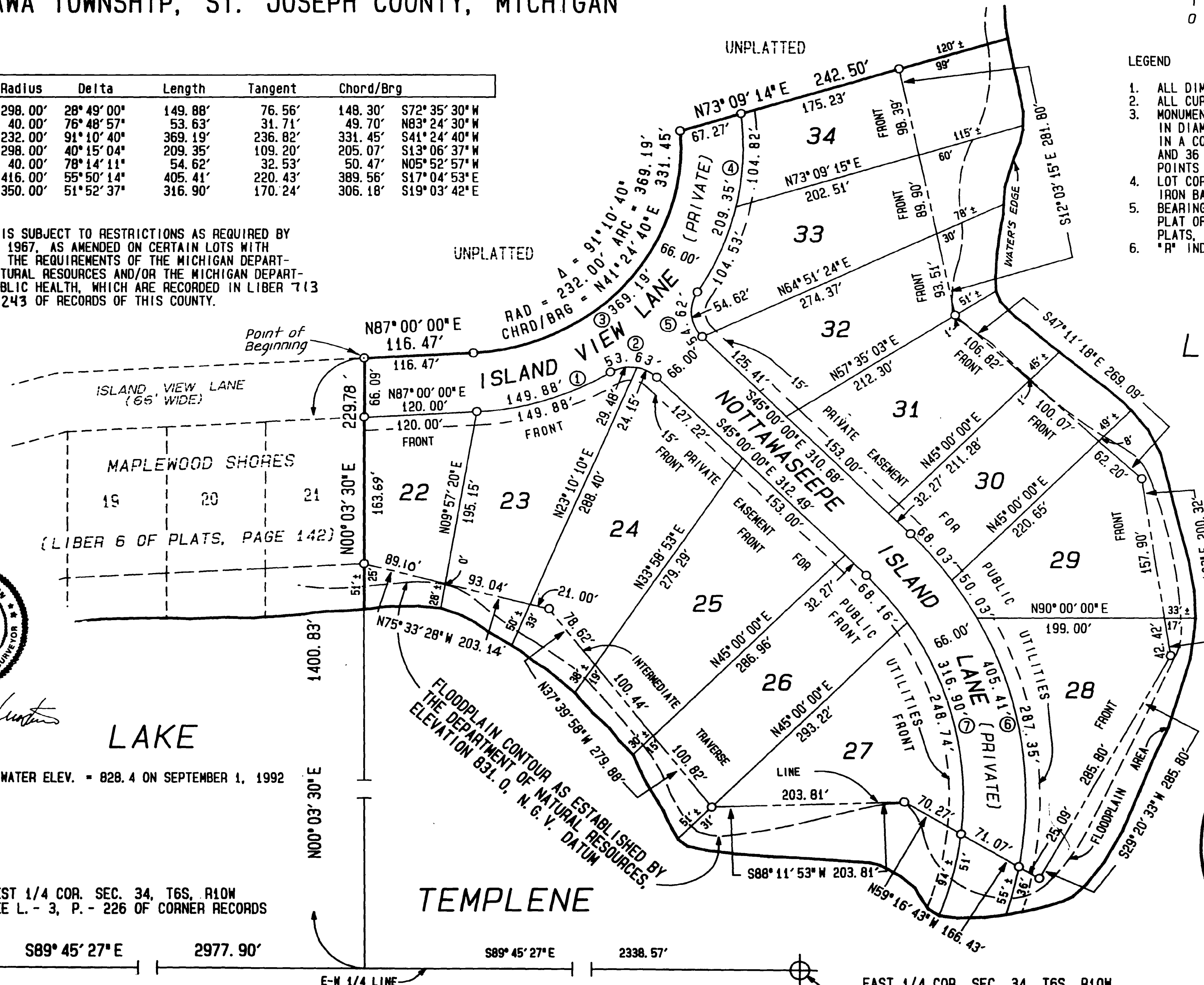

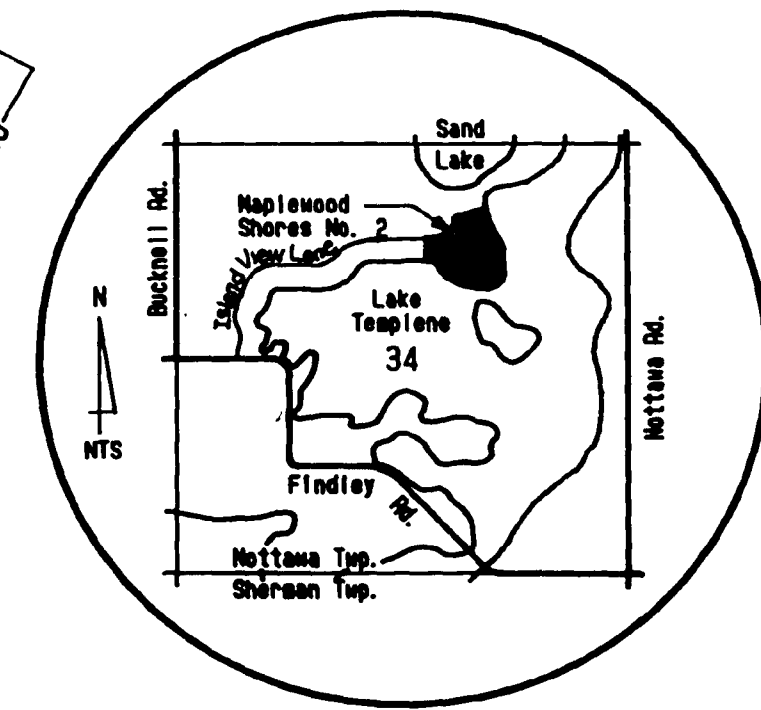
