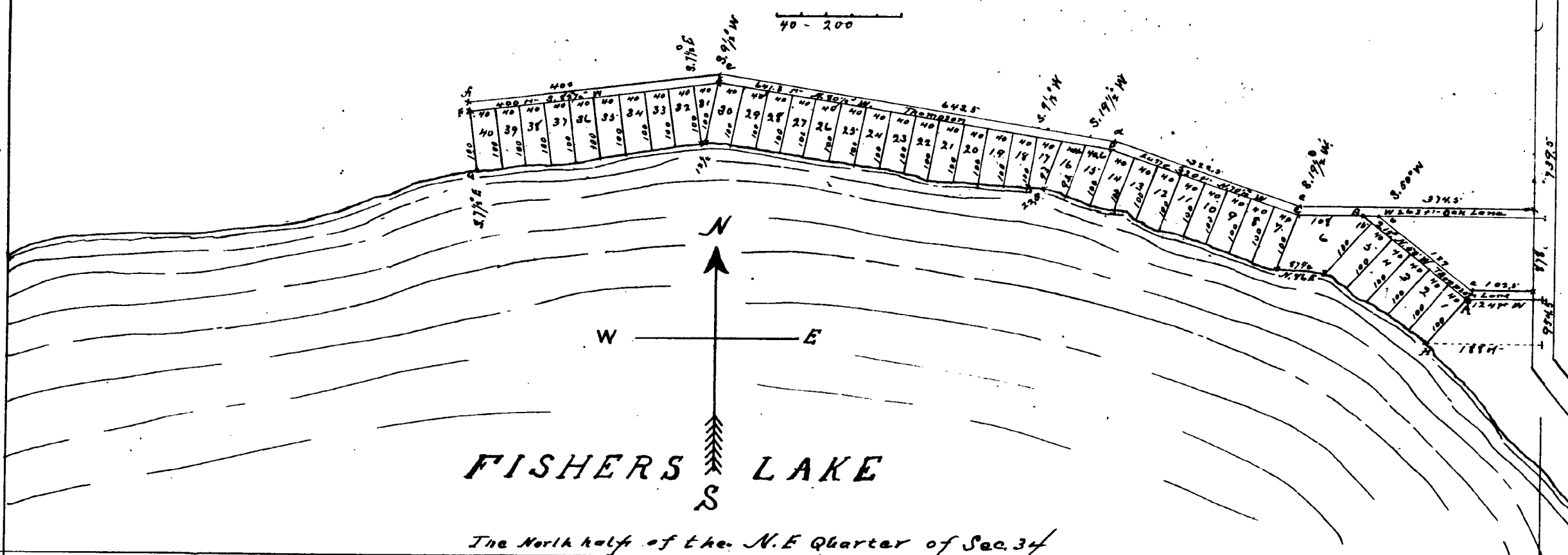


Description of Bertha Grove

A subdivision of the North half of the N.E. fractional quarter of section 34 Town 5 S, Range 11 W, St. Joseph County, State of Michigan, bounded as follows. Commencing at a piece of gas pipe firmly set in the ground said gas pipe being 8 1/2 ft S, on east line of Sec. 34 and 12 1/4 ft W of the N.E. cor. post of Sec. 34 Thence N. 50° W, 2 1/2 ft from A to B Thence W, 10 1/2 ft to C, Thence N. 70 1/2° W 32 0 ft to D Thence N. 80 1/2° W 6 4 1/3 ft to E Thence S 82 1/2° W 400 ft to F Thence S 7 1/2° E 100 ft to G on margin of Fishers Lake Thence easterly along said margin of Lake to H, a point 954.5 ft S and 18 1/2 ft W of said section cor. Thence N. 40° E 100 ft to place of beginning at A, each above mentioned station in the boundary line of plat indicated by the letters A to H, inclusive is marked by a piece of gas pipe 1/4 inch diameter 18" in length firmly set in the ground at each angle said points are also indicated by crosses + marked on plat. Commencing at a piece of gas pipe set in the ground said gas pipe being 8 1/2 ft S, on east line of section 34 run a line 12 1/4 ft W to A initial point of survey North of this line parallel and adjacent to it lay out Thompson Lane 16 1/2 ft wide, from highway to the N.E. cor. of plat A, Thence continue this parallel and adjacent to the N.E. boundary line of plat from A to B Thence parallel and adjacent to the N. boundary line B.C. Thence parallel and adjacent to the N.E. boundary line C.D. Thence parallel and adjacent to the N.E. boundary line D.E. Thence parallel and adjacent to the N.W. boundary line E to F. Commencing at a piece of gas pipe set in the ground said gas pipe being 7 3/4 ft S, on the east line of sec. 34 run a line 263 ft west to G North of this line parallel and adjacent to it lay out Oak Lane 16 1/2 ft wide extending from highway to the intersection of Thompson Lane.

The angles on the north side of Thompson Lane at A, B, C, D, E, F are also marked by gas pipes set in the ground in some manner as boundary line. All lines angles, sizes of lots and widths of lanes are as shown in plat. Contents of Plat 3.75 Acres.

The measurements on the north boundary of Thompson Lane are as follows. Commencing at the west line of highway 102.5 ft to a, 189 ft from a to b 322.5 ft - c to d 643.5 ft d to e 402.5 ft e to f. The measurements on the north boundary of Oak Lane are as follows. Commencing at the west line of highway 374.5 ft to e.

All lots except nos. 6, 15, 16, 17, and 31 are 40 ft in width extending at right angles from street or lane 100 ft to margin of Fishers Lake. Lot 6 measures from the N.W. cor. of lot 5 point B, N. 60° W 15 ft Thence W, 10 1/2 ft to the N.E. cor. of lot 7 point C, Thence S 19 1/2° W, 100 ft to margin of Fishers Lake Thence N. 86° E 87.5 ft to D, the S.W. cor. of lot 5. Thence N. 40° E 100 ft to place of beginning. Lot 15 measures from the N.W. cor. of lot 14 point D, N. 80° W 40 ft Thence S 19 1/2° W, 93 ft to margin of Fishers Lake Thence S.E. along margin of said Lake 40 ft to the intersection of the N.W. boundary line of lot 14 Thence N. 19 1/2° E 100 ft to place of beginning. Lot 16 measures from the N.W. cor. of lot 15 N. 80 1/2° W 40 ft Thence S 19 1/2° W, 93 ft to margin of Fishers Lake Thence S.E. along margin of said Lake 40 ft to the intersection of the N.W. boundary line of lot 15 Thence N. 19 1/2° E 93 ft to place of beginning. Lot 17 measures from the N.W. cor. of lot 16 N. 80 1/2° W, 40 ft Thence S 19 1/2° W 93 ft to margin of Fishers Lake Thence S.E. along margin of said Lake 22 1/2 ft to the intersection of the N.W. boundary line of lot 16 Thence N. 19 1/2° E 93 ft to place of beginning. Lot 31 measures from the N.W. cor. of lot 30 point E, S 89 1/2° W, 40 ft Thence S 7 1/2° E 100 ft to margin of Lake Thence E along margin of said Lake 12.5 ft to the intersection of the N.W. boundary line of lot 30 Thence N. 9 1/2° E, 100 ft to place of beginning point E. Survey completed Oct 6 1906.
