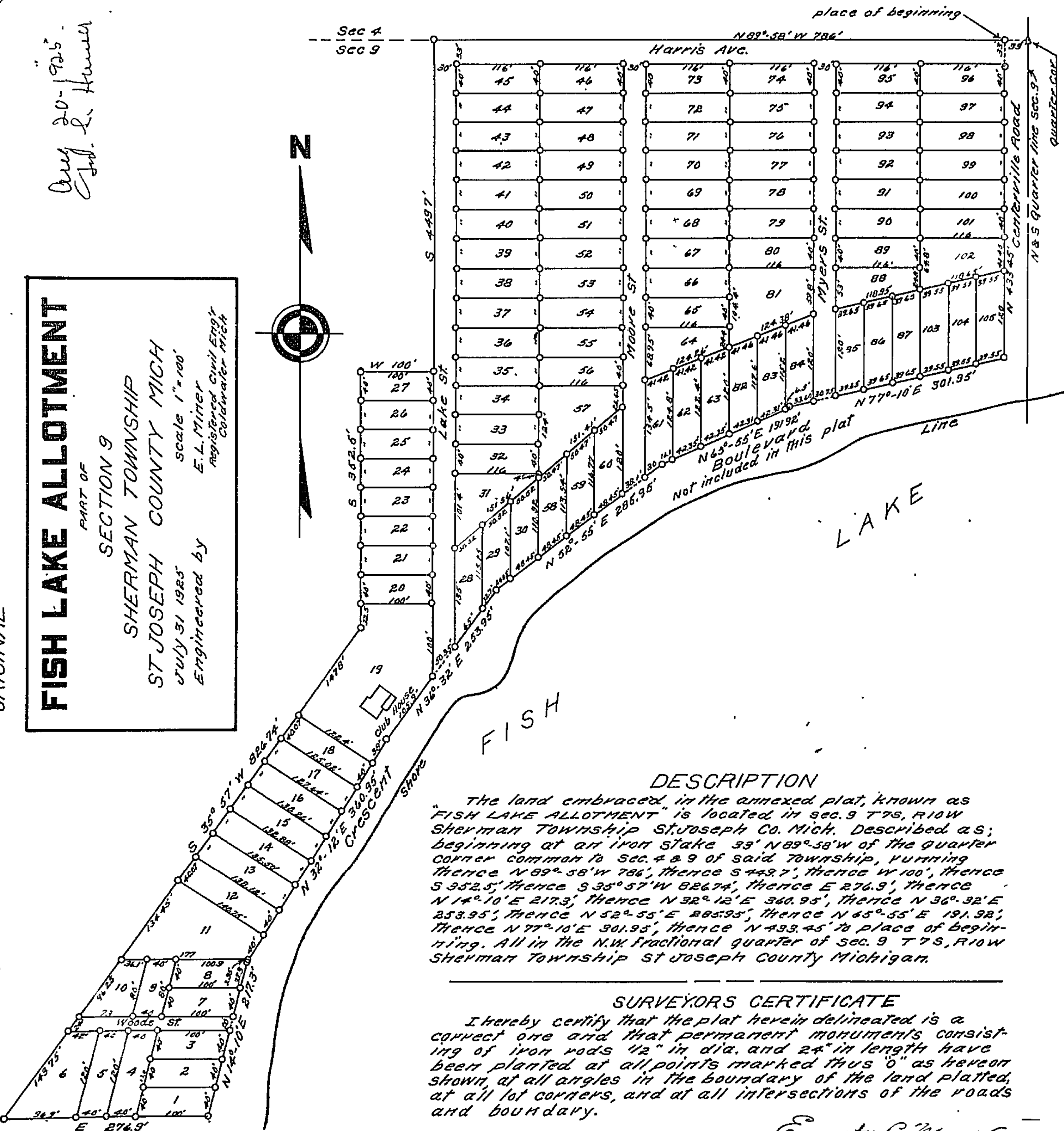

DESCRIPTION

The land embraced in the annexed plat, known as "FISH LAKE ALLOTMENT" is located in sec. 9 T7S, R10W Sherman Township St Joseph Co. Mich. described as; beginning at an iron stake 33' N89°-58'W of the quarter corner common to sec. 4 & 9 of said township, running thence N89°-58'W 786', thence S449.7', thence W100', thence S352.5', thence S35°-57'W 826.74', thence E276.9', thence N14°-10'E 217.3', thence N32°-12'E 360.95', thence N36°-32'E 253.95', thence N52°-55'E 285.95', thence N45°-55'E 191.92', thence N77°-10'E 301.95', thence N433.45' to place of beginning. All in the N.W. fractional quarter of sec. 9 T7S, R10W Sherman Township St Joseph County Michigan.
