



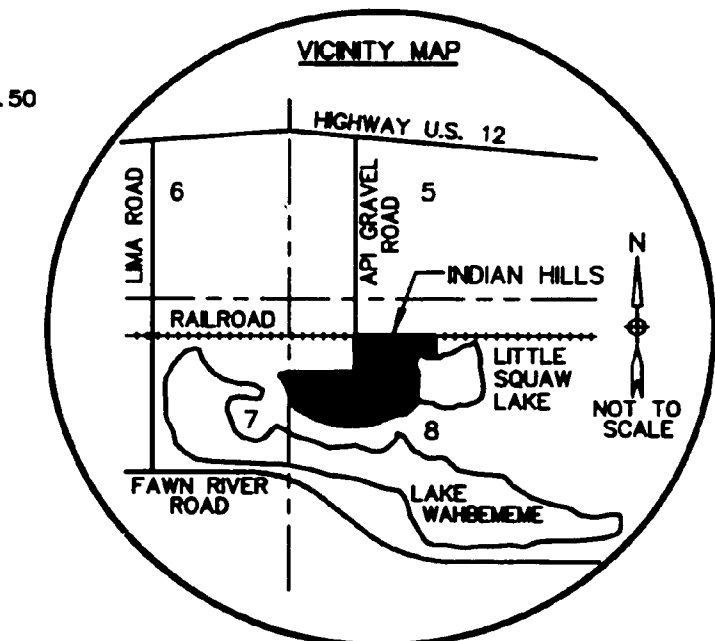
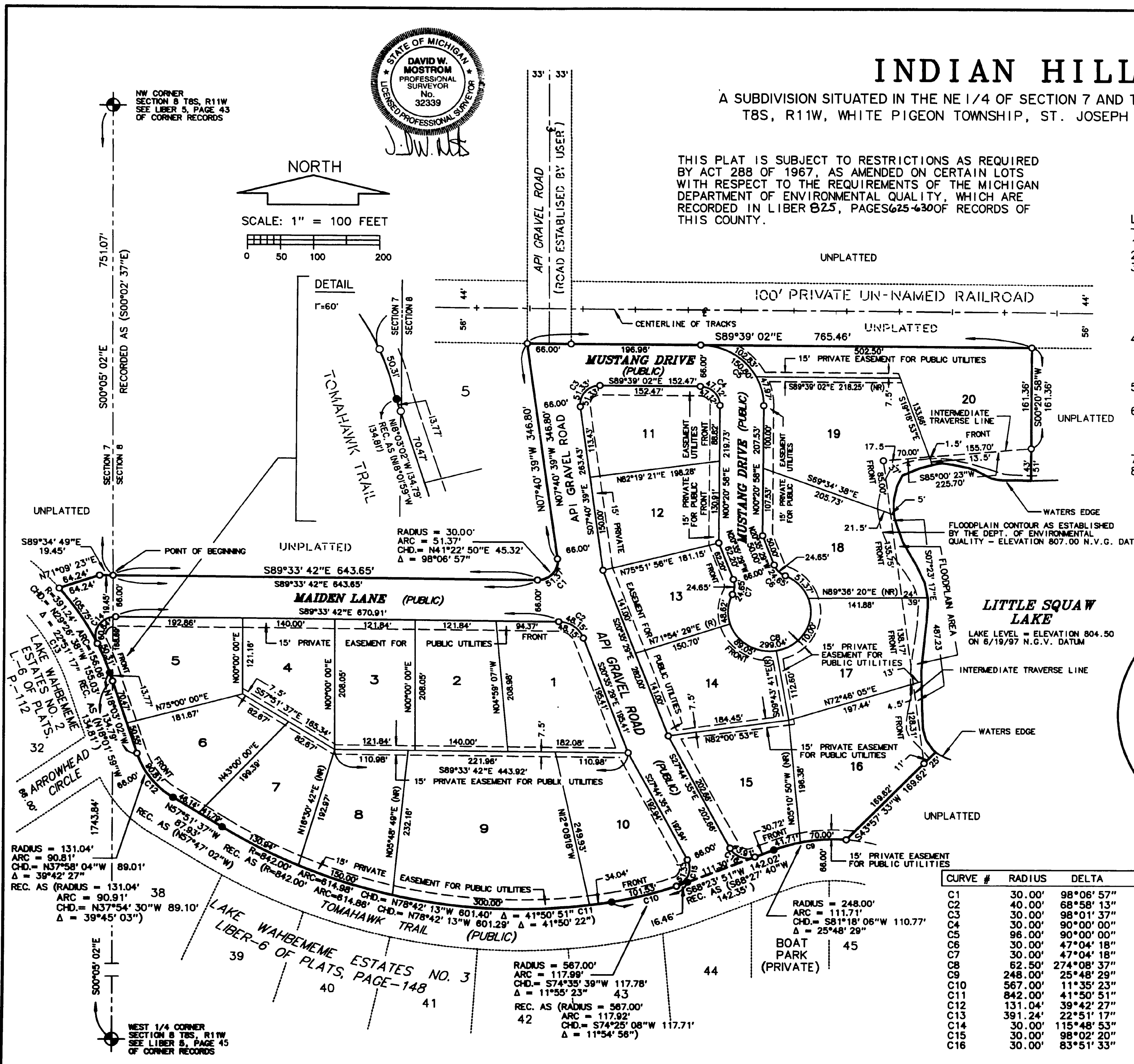
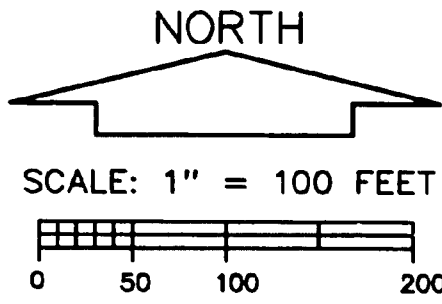
INDIAN HILLS
