R. 11 W. on the north and south half quarter line in the N.E. fractional quarter of section 7 said point of beginning being also 68 feet south of the N.W. corner of lot 15 Block 1 of the recorded plat of Mineral Springs, Proceeding West 424.5 feet to lake thence along the shore of lake N. 11° 30' E 80 feet thence N 21° 30' E 120 feet thence N 28° 30' E 280 feet thence N 38° 0' E 160 feet thence N 50° 0' E 40 feet thence N 71° 30' E 90 feet from this point south 1° 30' E 614 feet to point of beginning.
