**DESCRIPTION**  
SUPERVISOR'S PLAT NO. 1 OF WHITE PIGEON TOWNSHIP, A SUBDIVISION SITUATED IN THE NORTHWEST FRACTIONAL QUARTER OF SECTION 19, TOWN 8 SOUTH, RANGE II WEST, WHITE PIGEON TOWNSHIP, ST. JOSEPH COUNTY, MICHIGAN, AS DESCRIBED AS FOLLOWS:  
COMMENCING AT THE NORTHWEST CORNER OF SAID SECTION 19 AND RUNNING THENCE N89°29'E 62.57 FEET, THENCE N00°31'W 33.00 FEET TO THE POINT OF BEGINNING; THENCE N89°29'E 62.57 FEET, THENCE SOUTHEASTERLY ALONG A CURVE TO THE RIGHT WITH A RADIUS OF 988.37 FEET A DISTANCE OF 1230.31 FEET (SAID CURVE BEING SUBTENDED BY A CHORD THAT BEARS S54°51'22"E 1152.4 FEET), THENCE S60°W 235.39 FEET, THENCE N30°W 200 FEET, THENCE N42°01'W 318.77 FEET, THENCE N54°10'W 300.54 FEET, THENCE N60°01'27'W 140.25 FEET, THENCE N67°21'07'W 131.59 FEET, THENCE N00°31'W 74 FEET TO THE POINT OF BEGINNING. THIS SUBDIVISION CONTAINS 21 NUMBERED LOTS.
