E. corner of said section 25 and running thence S. 89° 53' W., along the south line of said Burr Oak Street, 552.8 feet; thence South 464.14 feet; thence N. 50° 46' E. 713.80 feet, along the northerly line of Main Street; thence north 13.9 feet to the place of beginning.

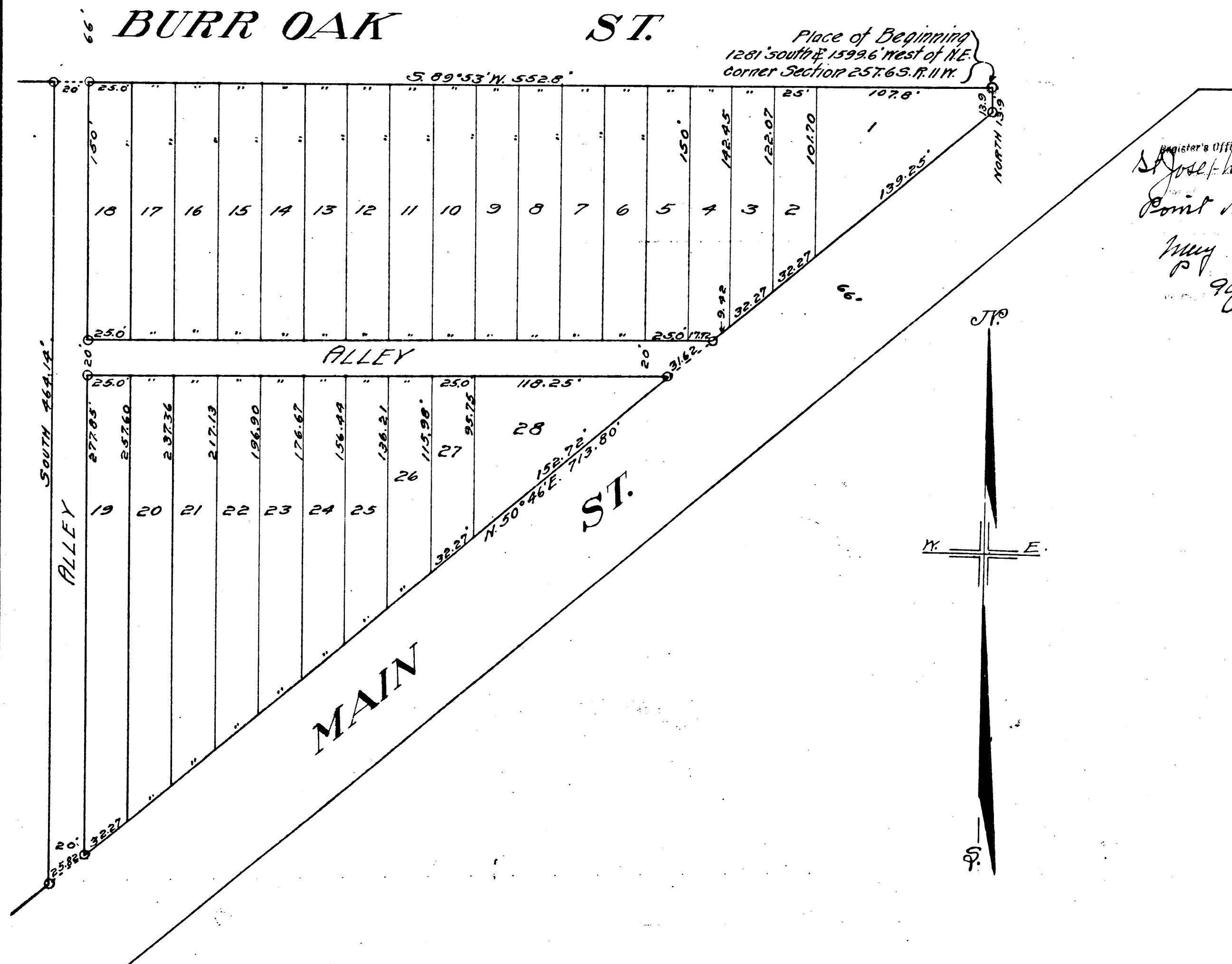
