Brown of the County and State aforesaid, one of the proprietors of the Bowman's Addition to the Village of Three Rivers, in the Township of Lockport, St. Joseph County, State of Michigan, who acknowledged that she owned the section of the Portage Addition annexed with the Bowman's Addition, according to the actual survey there of, and for the use and purpose therein set forth, and declared accordingly to the Statute of Michigan in such cases made and provided, and directed that same should be recorded as such.

Given under my hand at Columbia County, New York, this 25th day of January 1857. Samuel Crosby Justice. State of Pennsylvania) ss I, Joseph E. Eddy, Prothonotary of the Court of Common Pleas of the County of Columbia, aforesaid do hereby certify that Samuel Crosby Esq., before whom the within acknowledgment was taken, was duly sworn, and acting as such, and in all of the above official acts, as such also being duly credited are and ought to be given as well in the Courts of Justice as elsewhere and that under the laws of Pennsylvania he has full power to take acknowledgments of deeds for and in the County of Columbia, in this State, in testimony whereof I hereunto set my hand and affixed the seal of the said Court at Bloomsburg this twenty fifth day of January A.D. one thousand eight hundred and fifty seven.
