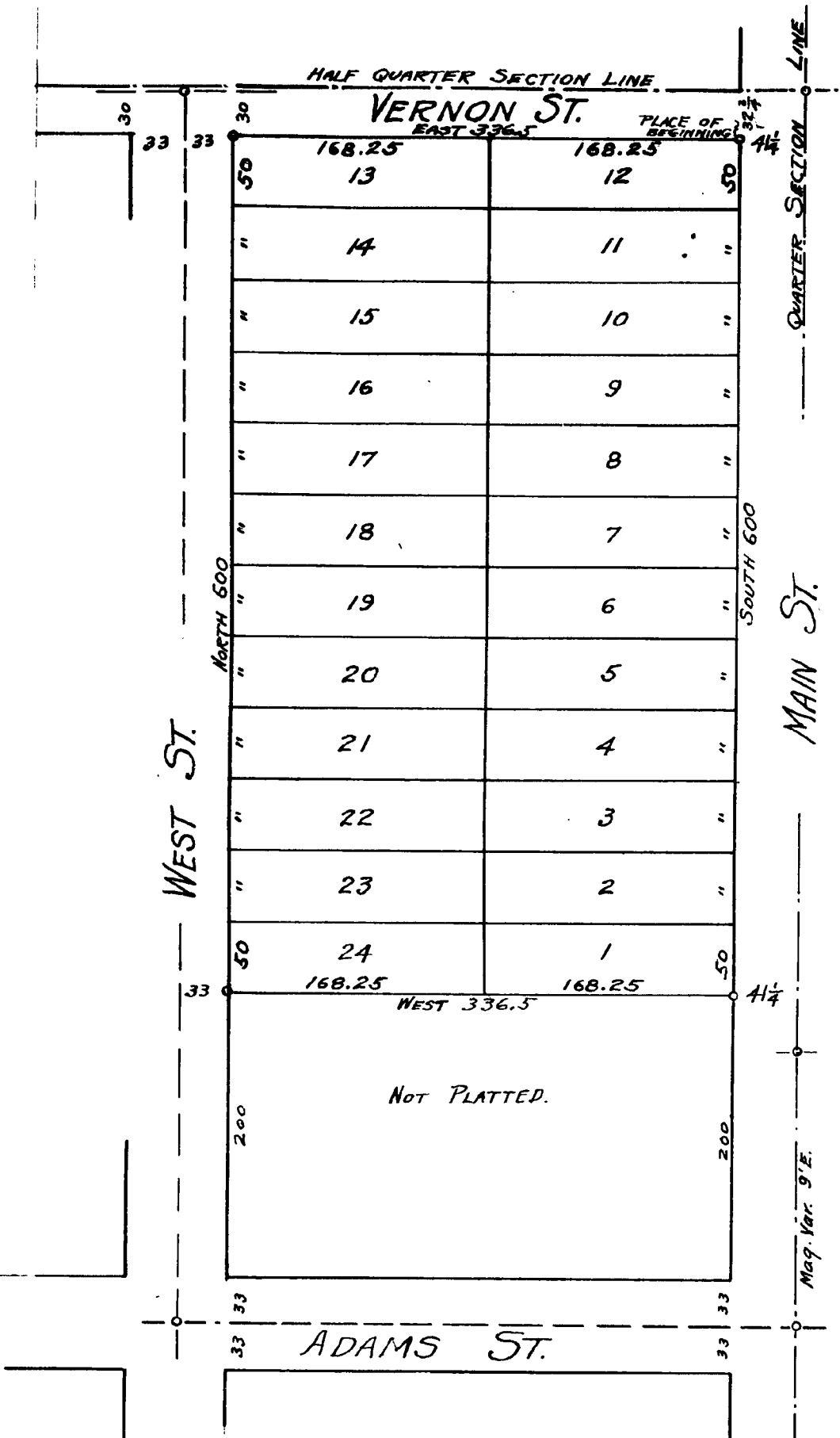

HAZEN'S ADDITION

DESCRIPTION

The land embraced in this plat of Hazen's Addition to the City of Three Rivers Mich. County of St. Joseph is bounded on the East by Main St., on the West by West St., and on the North by Vernon St., all of which streets have been previously dedicated or conveyed by deed to the City of Three Rivers Mich. Inc.

The land embraced in this plat of Hazen's Addition to the City of Three Rivers Mich. County of St. Joseph is described as a part of the S.E. 1/4 of S.W. 1/4 of Sec. 7 T.6S. R.11 W. bounded by beginning at an iron stake 32 3/4 feet south and 4 1/2 feet west of N.E. Corner of the S.E. 1/4 of S.W. 1/4 of said Sec. 7 and running thence south, parallel to quarter Sec. line, 600 ft; thence west 336.5 ft; thence north 600 ft; thence east 336.5 ft; to place of beginning.

DEDICATION

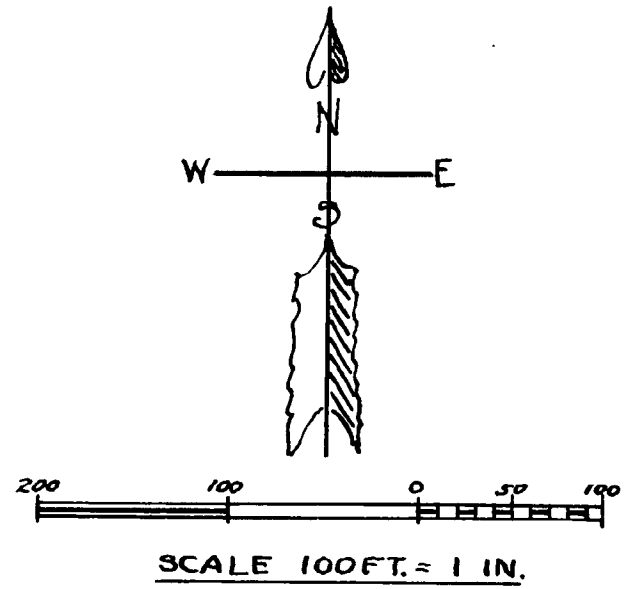
