

ASSESSOR'S PLAT OF WM.F. ARNOLD ADDITION TO THE CITY OF THREE RIVERS ST. JOSEPH CO. MICHIGAN

BEING A RESURVEY OF LANDS FORMERLY KNOWN AS WM. F ARNOLD ADDITION TO THE VILLAGE OF LOCKPORT



DESCRIPTION

The land embraced in this Assessor's Plat of Wm F Arnold Addition to the City of Three Rivers, St Joseph Co. Michigan is a part of the West one half of the West one half of the North West one forth of Section 20 T6 S11W described as follows Beginning at the Quarter Section corner between sections nineteen and twenty running along section line 2398 13 feet thence north thirty degrees east 291 3 feet to intersection with section line between sections seventeen and twenty, thence east 365.5 feet along section line, thence south 2646.9 feet to quarter section line thence west 510 feet to place 1 beg on 99

SURVEYOR'S CERTIFICATE

I hereby certify that the plat hereon delineated is a correct one and that permanent metal monuments of not less than one inch (1") in diameter and fifteen inches (15") in length set in a concrete base at least four inches (4") in diameter and forty eight inches (48") in depth have been placed at all points marked thus "o" as there are shown at all angles in the boundaries of the land platted, at all intersections of the streets with the boundaries and with each other.

All measurements are in feet and decimal's thereof thus 172.7'
