

Fourth St. 50' E of an iron stake at the S.E. corner of Lot #6 of Grove Addition, thence S89°-06' E 183' to the W. line of the East Lawn Addition, thence S0°-31' W 93.5' along the W. line of the E. Lawn Addition to the N. line of the Kensington Heights Addition, thence N89°-06' W 182.2' along the N. line of Kensington Heights to the N.W. corner of lot #5 of Kensington Heights (E. line of S. Fourth St.) thence N93.5' along the E. line of S. Fourth St. to place of beginning
