
LAKEVIEW MANOR

DESCRIPTION:

LAKEVIEW MANOR A SUBDIVISION IN THE NORTHWEST FRACTIONAL QUARTER OF SECTION 8, TOWN 8 SOUTH, RANGE 9 WEST, FAWN RIVER TOWNSHIP, ST. JOSEPH COUNTY, MICHIGAN, IS DESCRIBED AS FOLLOWS: BEGINNING ON THE EAST LINE OF LAKEVIEW AVENUE 33 FEET EAST OF THE WEST LINE OF SAID SECTION 6, AND 6 FEET NORTH OF THE EAST AND WEST QUARTER LINE AND RUNNING NORTH 614 FEET, THENGE NORTH 69 DEGREES 46 MINUTES EAST 2756 FEET TO THE NORTH AND SOUTH QUARTER LINE, THENGE SOUTH 625.0 FEET TO THE GENTER OF SAID SECTION, THENGE NORTH 69 DEGREES 49 1/2 MINUTES WEST 1016.17 FEET, TO THE NORTHEAST CORNER OF THE ARDEN PARK ADDITION, THENGE SOUTH 89 DEGREES 48 MINUTES WEST 939.83 FEET TO BEGINNING:
