

JOSEPH COUNTY, MICHIGAN, IS DESCRIBED AS FOLLOWS: COMMENCING AT THE NORTHWEST CORNER OF SECTION 7, TOWN 8 SOUTH, RANGE 9 WEST, FAWN RIVER TOWNSHIP. ST. JOSEPH COUNTY MICHIGAN AND RUNNING SOUTH ALONG THE RANGE LINE 48.30 FEET, THENCE MORTH 89 DEGREES 41 MINUTES IS SECONDS EAST PARALLEL WITH THE NORTH LINE OF SAID SECTION 7 A DISTANCE OF 466.70 FEET TO THE POINT OF BEGINNING; THENCE SOUTH PARALLEL TO SAID KANGE LINE 100 FEET, THENCE NORTH 89 DEGREES 41 MINUTES IS SECONDS EAST PARALLEL WITH SAID NORTH LINE OF SECTION 7 FOR 996.04 FEET, THENCE NORTH OO PEGREES OB MINUTES OO SECONDS EAST ALONG THE EAST LINE OF THE WEST HALF OF THE NORTHWEST QUARTER OF SAID SECTION 7 A DISTANCE OF 100 FEET, THENCE SOUTH 69 DEGREES 41 MINUTES IS SECONDS WEST PARALLEL TO SAID NORTH-LINE OF SECTION 7 FOR 996.27 FEET TO THE POINT OF BEGINNING, THIS PLAT CONTAINS IO NUMBERED LOTS.
