

#### Highlights of Exercises, Trainings, and Events in 2022

#### January-March

- Delivered the FEMA/MSP Student Tools for Emergency Planning (STEP) program to 5<sup>th</sup> grade students in three school districts, promoting awareness for creating family community plans and creating emergency kits
- Monitored and coordinated communication with local partners during minor flood event
- Conducted community outreach for severe weather awareness through presentations to the Three Rivers Lions Club and local Boy Scout Troops

### April-June

- · Collaborated with local agriculture partners to exercise protocols in a pesticide exposure drill
- Emergency Services Director attained the Professional Emergency Manager designation through the Michigan State Police Emergency Management & Homeland Security Division
- Completed the four-year update to the St. Joseph County Emergency Operations plan

#### July-September

- · Provided school safety training to districts throughout the county
- Delivered a severe weather awareness presentation for community outreach to the Sturgis Lions Club
- Conducted an Emergency Operations Center orientation session for partner agencies
- Co-organized a Regional Full-Scale Exercise, testing collaborative plans with specialty response teams

#### October-December

- · Organized instructor training for school safety
- Provided civilian training for active shooter events (CRASE program)
- Participated in hydroelectric dam exercise, testing components of the St. Joseph County Emergency Operations Plan
- Coordinated emergency sheltering assistance following water and heat loss due to near-record low temperatures

Also deployed vehicles, trailers, generators, and radios to trainings, incidents, and events as needed.
