An election will be held in St. Joseph, Branch, and Kalamazoo Counties on Tuesday, May 7, 2024.

Persons planning to register may do so in person at the City or Township Clerk’s Office, the Secretary of State branch office, County Clerk’s Office, or other designated state agency during regular business hours. Instructions to register by mail or online are available at www.mi.gov/vote. Those already registered may update their voter registration at www.expressSOS.com.

The last day to register for the election in any manner other than in person with the local clerk is **April 22, 2024**. Persons residing in the county registering after the deadline will need to register with the local clerk in-person with proof of residency at the following locations:
