RESERVATION INFO:

Campsites are available for reservation after January 15. Sites may be reserved in advance, out-of-season, by calling St. Joseph County Parks at (269) 467-5519. To check immediate campsite availability May - October, contact Cade Lake County Park at (269) 651-3330.

OTHER:

Additional car passes, day-use passes, annual park passes, pavilion rental, firewood, snacks, fishing supplies and boat rentals are available in our office/store. Please review the Park Rules.



PARK RULES:

Respect Yourself. Respect Others. Respect the Park.

1. Do not set up campers/tents until a campsite is assigned and fees are paid.
2. Camping fees are nonrefundable.
3. Occupancy limited to immediate family or up to four single persons.
4. Not more than one RV/trailer and one tent, or two tents and no trailer will be permitted per campsite. All camper trailers must be **backed** into your campsite.
5. No "recreational unit" (RV/trailer) may be placed on any Camping Cabin Site. Only one tent may be placed on each site.
6. Camping permits shall be issued for no more than 14 consecutive days. Permits may be renewed after the required separation period. **After 14 days, patrons must vacate the campground for a minimum of 48 hours.**
7. Anyone camping, under the age of 18 shall be accompanied by an adult.
8. Check in time is 3:00pm. Check out time 1:00pm.
9. Camping permits must be renewed on or before the initial expiration date, subject to availability. Failure to renew permit prior to expiration will result in removal of site contents at the owner's expense.
10. Quiet time is 10:00pm - 7:00am. ALL visitors must leave by 10:00pm. The camp host is available for **EMERGENCIES ONLY** after 6:00pm.
11. Alcoholic beverages are permitted at registered campsites only, and are prohibited in day-use areas.
12. Fires are permitted only in fire pits and grills only. Collecting firewood at Cade Lake County Park is prohibited. Firewood is for sale at the camp store.
13. Fireworks are not permitted.
14. Campsites shall not be left unoccupied for more than 48 hours.
15. One vehicle per site. Additional vehicles and guest vehicles must be parked in the day-use parking lot and must display a day-use pass; fee is \$5.00 per day per vehicle.
16. Pets must be on a leash no more than 6 feet long at all times. No pet can be left unattended at any time. Owners must clean up after pets immediately. Pets are not permitted on or near the swimming beach. No pets are allowed inside any of the Camping Cabins.
17. Waste-water lines must be fastened securely to sewer connection according to State health regulations.
18. Private watercraft may not be utilized until they have been sanitized and dried to remove invasive aquatic species. Gas powered motors are prohibited.
19. No person shall engage in any violent, abusive, boisterous, loud, illegal, obscene or similar disorderly conduct which interferes with another person's use or enjoyment of the park. Radios, generators or other device that creates excessive noise is prohibited..
20. **CHOOSING TO VIOLATE ANY ST. JOSEPH COUNTY PARKS OR CADE LAKE CAMPGROUND RULES WILL RESULT IN EVICTION AND/OR PROSECUTION.**
