



CONTRACT FOR PROFESSIONAL SURVEYING SERVICES

THIS CONTRACT made and entered into this [] day of [] 2025 (the "Effective Date") by and between the County of St Joseph (hereinafter referred to as the "County"), of 125 West Main Street, Centreville, MI 49032 and Southwest Survey & Engineering LLC (hereinafter referred to as the "surveyor"), a professional surveyor with offices at 214 W. Michigan Avenue, Paw Paw, MI 49079.

WITNESSETH:

WHEREAS, the County has approved a remonumentation plan which was approved by the Michigan State Survey and Remonumentation Commission; and

WHEREAS, it is the intent of the County to remonument all "Remonumentation Corners" as defined by the Michigan State Survey and Remonumentation Act, Act 345 of 1990, R 54.201; and

WHEREAS, the County has received grant monies from the State of Michigan to execute this plan and requires the assistance of professional surveyors who work within the boundaries of the County.

NOW, THEREFORE. In consideration of the mutual covenants and promises hereinafter contained, the parties hereto agree as follows:

1. **SERVICES TO BE RENDERED.** The surveyor agrees to perform the following services ("Services") at real property located at various section corner locations:
 - A. Submit corner-position documentation to the Peer Group of the St Joseph County Remonumentation Program (the "Peer Group") for recommendation of a monument location.
 - B. After ratification of the monument location by the Peer Group, the Surveyor shall properly install a standard marker as supplied by the County.
 - C. After installation of the standard marker the Surveyor shall obtain geodetic coordinates on the corner based on the requirements outlined in the memorandum dated October 16, 2014 from Chris Beland, the Director of the Office of Land Survey and Remonumentation (OLSR) or another representative from the County.

- D. Finally, the surveyor shall file the newly adopted 2025 Land Corner Recordation Certificate from the OLSR with the County Surveyor.
2. **SECTION CORNER MAINTENANCE**. For a previously ratified corner that has been damaged or obliterated, the County may select a local survey firm to remonument the corner.
 3. **RIGHT OF ENTRY**. County will, in its sole direction, furnish Surveyor, its agents, employees, and subcontractors a right-of-entry and any other authorizations or licenses needed for Surveyor to enter the location to perform the Services contemplated by this Contract.
 4. **PRICE AND PAYMENT TERMS**. In consideration of performing the aforementioned Services, the County shall reimburse the Surveyor according to the attached Schedule "A". The Board of Commissioners may annually revise this schedule upon recommendation of the County Representative and County Grant Administrator.
 5. **TERM**. The term of this contract shall be from the Effective Date until terminated as prescribed herein.
 6. **TERMINATION**.
 - A. **FOR CONVENIENCE**. Upon 30 days prior written notice, County may terminate this Contract for convenience. Upon the effective date of such termination notice, Surveyor shall cease work on all Services set forth in this Contract.
 - B. **FOR CAUSE**. In the event of a material breach of this Contract, the non-breaching party may terminate this Contract upon 15 days written notice to the breaching party, which notice must identify the material breach. Upon receipt of such termination notice for cause, the breaching party shall have 15 days in which to cure the breach (the "Cure Period"). Should the breaching party timely cure its material breach of this Contract, this Contract may not be terminated for cause. Should the breaching party fail to timely cure its material breach, this Contract shall be terminated, effective at the end of the Cure Period. Upon the effective date of such termination for cause, Surveyor shall cease work on all Services set forth in this Contract.
 7. **APPROVAL BY COUNTY BOARD OF COMMISSIONERS**. As required by the County Remonumentation Plan, this contract must be submitted to the County Board of Commissioners for its approval and its authorization for execution.

8. **STANDARD OF CARE.** Surveyor's Services shall be conducted with the same level and degree of skill ordinarily exercised by members of its profession operating in a similar locality, at a similar time and under similar conditions and circumstances.
9. **DATE OF COMPLETION.** Surveyor shall complete all Services by or before (12/31/24).
10. **INDEMNIFICATION.** Surveyor shall indemnify and save harmless County and its officers, agents and employees from, and, if requested, shall defend them against any and all loss, cost, damage, injury, liability, and claims thereof for injury to or death of a person, including employees of Surveyor or loss of or damage to property, arising directly or indirectly from Surveyor's performance of this Contract, including, but not limited to, Surveyor's use of facilities or equipment provided by County or others, regardless of the negligence of, and regardless of whether liability without fault is imposed or sought to be imposed on Surveyor, except to the extent that such indemnity is void or otherwise unenforceable under applicable law in effect on or validly retroactive to the date of this Contract, and except where such loss, damage, injury, liability or claim is the result of the active negligence or willful misconduct of Surveyor and is not contributed to by any act of, or by any omission to perform some duty imposed by law or Contract on Surveyor, its subcontractors or either's agent or employee. The foregoing indemnity shall include, without limitation, reasonable fees of attorneys, consultants and experts and related costs and County's costs of investigating any claims against the County.
11. **INDEPENDENT CONTRACTOR.** The Surveyor and its employees, agents, representatives, and subcontractors are independent contractors and not employees or agents of the County. The County will not be bound by any acts or conduct of the Surveyor or its employees, agents, representatives, or subcontractors. The Surveyor agrees to include this provision in all its subcontracts under the Contract.
12. **INSURANCE.** Surveyor shall maintain at its own expense the following insurance: (1) Worker's Compensation Insurance, in the form and amounts required by statute or other applicable law; (2) Employer's Liability Insurance with a limit of \$1,000,000; (3) Commercial Automobile Liability Insurance with a combined single limit of \$500,000 (4) Commercial General Liability Insurance with limits of \$1,000,000 per occurrence; and (5) Professional Liability Insurance with limits of \$2,000,000. Certificates of insurance shall be issued by Surveyor upon County written request.



Should any part, provision, term or condition of this Contract be declared, decreed or determined by any court of competent jurisdiction to be illegal, invalid or unenforceable as part of a final, non-appealable ruling, the legality, validity or enforceability of the remaining parts, provisions, terms or conditions shall not be affected thereby and the remainder of the Contract shall be given full force and effect. Neither party may assign this Contract, in whole or in part, without the prior written consent of the other party, except for an assignment of proceeds for financing purposes. Surveyor may subcontract for the services of others upon obtaining County's consent if Surveyor deems it necessary or desirable to have others perform services necessary to the successful completion of the project. This Contract shall be binding upon and inure to the benefit of the successors and assigns of the parties hereto. No action or failure to act by Surveyor or County shall constitute a waiver of any of its rights or remedies that arise out this Contract, nor shall such action or failure to act constitute approval, acquiescence, or ratification of a breach hereunder, except as may be specifically agreed to in writing or as otherwise provided in this Contract. Unless otherwise provided in this Contract, all of the terms, provisions, representations and warranties, and all remedies available to any party, shall survive the expiration or sooner termination of this Contract. All provisions in this Contract constituting representations, making or limiting warranties, limiting liability, allocating risk, or for indemnification specifically survive this Contract. This Contract constitutes the entire

Contract and understanding between the parties relating to the Services and supersedes any and all prior negotiations, discussions, and contracts, whether written or oral, between the parties regarding same. This Contract may not be modified or amended in any manner except in writing and signed by the parties. CONTRACT FOR PROFESSIONAL SURVEYING SERVICES

THIS CONTRACT made and entered into this [____] day of [_____] 2025 (the “Effective Date”) by and between the County of St Joseph (hereinafter referred to as the “County”), of 125 West Main Street, Centreville, MI 49032 and RD Miller Land Surveying (hereinafter referred to as the “surveyor”), a professional surveyor with offices at PO Box 309, Olivet, MI 49076.

WITNESSETH:

WHEREAS, the County has approved a remonumentation plan which was approved by the Michigan State Survey and Remonumentation Commission; and

WHEREAS, it is the intent of the County to remonument all “Remonumentation Corners” as defined by the Michigan State Survey and Remonumentation Act, Act 345 of 1990, R 54.201; and

WHEREAS, the County has received grant monies from the State of Michigan to execute this plan and requires the assistance of professional surveyors who work within the boundaries of the County.

NOW, THEREFORE. In consideration of the mutual covenants and promises hereinafter contained, the parties hereto agree as follows:

1. **SERVICES TO BE RENDERED.** The surveyor agrees to perform the following services (“Services”) at real property located at various section corner locations:
 - A. Submit corner-position documentation to the Peer Group of the St Joseph County Remonumentation Program (the “Peer Group”) for recommendation of a monument location.
 - B. After ratification of the monument location by the Peer Group, the Surveyor shall properly install a standard marker as supplied by the County.
 - C. After installation of the standard marker the Surveyor shall obtain geodetic coordinates on the corner based on the requirements outlined in the memorandum dated October 16, 2014 from Chris Beland, the Director of the Office of Land Survey and Remonumentation (OLSR) or another representative from the County.

- D. Finally, the surveyor shall file the newly adopted 2025 Land Corner Recordation Certificate from the OLSR with the County Surveyor.
2. **SECTION CORNER MAINTENANCE**. For a previously ratified corner that has been damaged or obliterated, the County may select a local survey firm to remonument the corner.
 3. **RIGHT OF ENTRY**. County will, in its sole direction, furnish Surveyor, its agents, employees, and subcontractors a right-of-entry and any other authorizations or licenses needed for Surveyor to enter the location to perform the Services contemplated by this Contract.
 4. **PRICE AND PAYMENT TERMS**. In consideration of performing the aforementioned Services, the County shall reimburse the Surveyor according to the attached Schedule "A". The Board of Commissioners may annually revise this schedule upon recommendation of the County Representative and County Grant Administrator.
 5. **TERM**. The term of this contract shall be from the Effective Date until terminated as prescribed herein.
 6. **TERMINATION**.
 - A. **FOR CONVENIENCE**. Upon 30 days prior written notice, County may terminate this Contract for convenience. Upon the effective date of such termination notice, Surveyor shall cease work on all Services set forth in this Contract.
 - B. **FOR CAUSE**. In the event of a material breach of this Contract, the non-breaching party may terminate this Contract upon 15 days written notice to the breaching party, which notice must identify the material breach. Upon receipt of such termination notice for cause, the breaching party shall have 15 days in which to cure the breach (the "Cure Period"). Should the breaching party timely cure its material breach of this Contract, this Contract may not be terminated for cause. 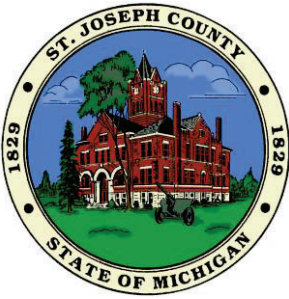

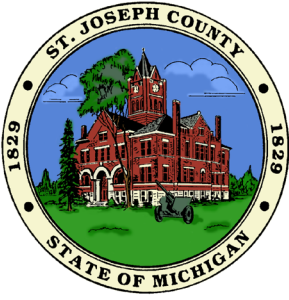
DESCRIPTION OF ACTION/BACKGROUND (dollar amount, purpose):

Greetings!

As I look back on 2024 and what the Commission on Aging provided to older adults in St. Joseph County, I am incredibly proud of the work our agency did to serve, protect and support some of the most vulnerable people in our community. In addition to helping seniors receive nutritious meals or help in their home so they could remain independent, we also operate two centers that offer a wide range of programs to help keep older adults in our community healthy and engaged.

Studies show that seniors with strong social connections and community engagement often experience better physical and mental health outcomes, including reduced risk of chronic diseases and improved cognitive function. The Commission on Aging plays an essential role in providing seniors with a place to go to make those strong social connections. We offer close to two dozen exercise classes at our centers each week, in addition to arts and crafts, lectures, health screenings, card games and so much more.

As you read through this report, you will see that whether it is providing food to seniors who would struggle to prepare a meal on their own, or offering an aide to help a senior take a shower and have a clean house to live in, or an enrichment center where a senior can go to talk to other seniors, eat lunch and play a card game, the Commission on Aging is providing older adults in our community with the support they need to stay healthy, safe and independent.

Nutrition Services

The Nutrition Department had a fun-filled year of special celebrations for seniors who came to eat at our centers, and for those who received home-delivered meals.

Some ways we blended nutrition and activities at the centers were with themed desserts and other fun food items such as chocolate chip cookies and ice cream during Women's History Month, kerosene pickles for Ron Howard's birthday, a cookout for Older Americans Month, and much more. Our seniors were happy to learn that it was women who invented chocolate chip cookies and the ice cream maker.

The Nutrition Department also provided the food for several special celebrations such as the Volunteer Breakfast, the Summer Picnic, the Water Festival Luncheon, the Holiday Party, and Dogs and Donuts, just to name a few.

Presentations were made at both centers on nutrition topics, such as cooking with grains, and included samples and recipes to allow the seniors the opportunity to taste things they might not have a great deal of familiarity with, while also giving them education about the health benefits of eating particular foods.

The COA received the Community Agency of the Year Award from the St. Joseph County Intermediate School District's Parent Advisory Committee for its work with YATC. Throughout the school year the COA welcomed students in the program to help pack item for Meals on Wheels and perform a multitude of tasks commonly performed in commercial kitchens to help develop their job skills.

In 2024 the Nutrition Department served more than 200,000 meals. Approximately 550 seniors at our centers and almost 500 seniors received home delivered meals. About 1,700 seniors participated in our restaurant program, which is a program where the seniors can purchase up to three coupons each month for a suggested donation of \$5.00 to eat at area restaurants. This ensures seniors have an opportunity to receive much needed socialization.

Many of the seniors who receive meals in the home are socially isolated. Groups of volunteers from the Young Adult Transitions Center, Immaculate Conception School and Girls on the Run from Andrews Elementary created cards and assembled treats that were distributed to our Meals on Wheels recipients on a regular basis, which let them know that they are important to us and we care about their well-being.

Residential Services



Residential Services at the COA saw a slight decrease in 2024. The COA served 157 vulnerable adults in St. Joseph County, providing a total of 8,758 hours for homemaking, personal care and respite care services. In serving the most vulnerable adults in St. Joseph County, homemaking services were found to be the most needed service in 2024 with a total of 7,606 hours for this year. Respite care to caregivers was utilized for 587 hours and personal care for 555 hours. The COA held an average staff of 12 in-home aides during 2024 and dropped to 8 active aides later in the year. As a result, the program was able to manage an ongoing waitlist of clients requesting services. The COA also provided chore services to clients through a part time chore worker to help seniors with heavier duty chores in their homes such as yardwork, installing grab bars and small handy-man tasks. This program utilized 32 hours in the year 2024.

The apartments at the Rivers Enrichment Center have remained a valuable resource to our community. During 2024, there was a turnover of ten apartments, which were able to be filled from a robust waiting list within a few short days. Interest in senior housing at Rivers Residences remains strong, with our waiting list continuing to grow - reflecting a consistent and vested demand within the community. We experience a steady stream of seniors scheduling tours and joining our list with genuine enthusiasm and intent to make Rivers their home. The apartment community itself continues to thrive, fostering close-knit relationships among residents. Daily gatherings for coffee, conversation, games, potlucks, and social events illustrate the deep sense of connection and belonging shared among our residents.

Participation in COA programs remains high, with many residents actively engaging in enrichment activities offered right within the building. This unique integration of housing and enrichment creates a dynamic environment that supports both social engagement and well-being without the need to leave home.

Rivers Enrichment Center and Residences continues to serve as a cornerstone for senior living in our county. We are proud of the meaningful impact we've made in the lives of our residents and look forward to continued growth, community engagement, and excellence in senior care.

Life Enrichment



Our members enjoyed a wide range of activities in 2024 to help keep them healthy, active and engaged. The highlights of 2024 include our annual summer picnic as well as our holiday party. Both events drew more than 150 participants. Throughout the year there were many other events our members enjoyed in addition to the daily programming we offer such as exercise classes, cards and games, crafts and more.

We celebrated Women's History Month with lectures from local historians, we celebrated National Pretzel Day with warm soft pretzels for our seniors to enjoy, and we celebrated Older Americans Month with a cookout provided by the Nutrition Department followed by an afternoon of fun games. This is just a small sampling of the special days we celebrated throughout the year with games and other activities, guest speakers and special treats.

Our trip program was very popular with 44 trips offered in 2024 and almost 200 seniors who participated in at least one trip. This represents a 50 percent increase in the number of trips offered in 2023. We visited the Henderson Castle in Kalamazoo, the University of Notre Dame in South Bend and Meadowbrook Hall in Rochester Hills. One of the highlights of the year was an outing to see the Detroit Tigers. More than two dozen seniors enjoyed a wonderful afternoon at the ballpark.

In June the COA offered a special dinner and presentation called *Mrs. Kelly's Journey Home* that shed a spotlight on the stress of caregiving, especially when your loved one has dementia. The event featured professional speaker, author and storyteller Breeda Miller and drew 180 people.

In 2024, the COA offered 30,000 hours of activities at its centers in Sturgis and Three Rivers. More than 1,300 individuals visited our centers, resulting in almost 52,000 sign-ins to exercise classes, Bingo, crafts, educational presentations & more.

The COA offered more than 2,000 hours of exercise classes at its centers in 2024. Several of the classes receive grant funding to help offset the cost of our instructors' salaries. Those classes are classified as Evidence Based Disease Prevention programs and help combat the effects of arthritis exercise or lower the risk of falling.

One area we saw a significant increase in usage at both our centers is the fitness rooms. For members who might not want to participate in a group exercise class, our fitness rooms feature a variety of equipment for seniors to use to help keep them healthy and fit.

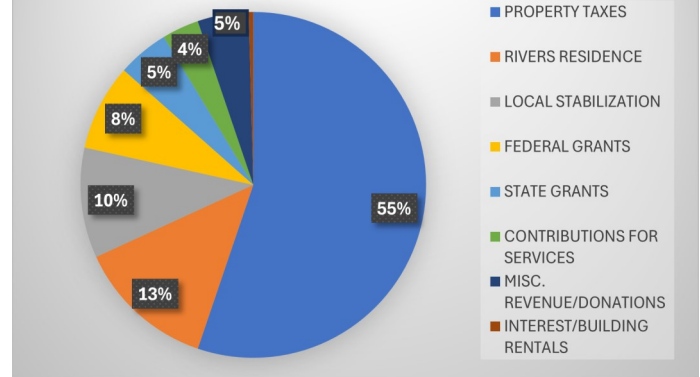

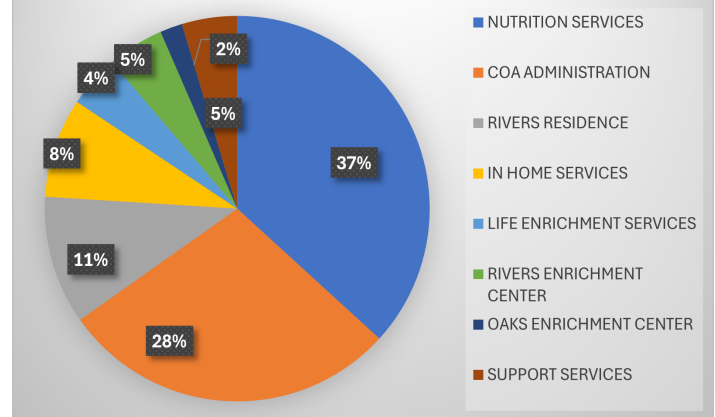

St. Joseph County Commission on Aging

BYLAWS

- SECTION 1. Name:** The Commission on Aging shall be called the St. Joseph County Commission on Aging, hereafter referred to as the COA.
- SECTION 2. Origin:** The COA was established by a unanimous vote of the St. Joseph County Board of Commissioners in September of 1973 as the officially designated local body to provide for and plan services for senior citizens of St. Joseph County.
- SECTION 3. Purpose:** The COA shall have as its basic purpose the establishment of and provision of services to aging persons in the County, and shall encourage, promote, assist, or safeguard the rights and abilities of our older people to maintain maximum health, well-being, and independence.
- SECTION 4. Duties:** It shall be the duty of the COA Board to do the following:
- a. Provide leadership, consultation and assistance to governmental bodies, agencies, and individuals, who are charged with responsibility for or who provide services to aging persons.
 - b. Acquire, accumulate, compile, evaluate and study data relating to aging persons and the resources available to promote the purpose of the COA.
 - c. Provide, publish, or otherwise make known to interested persons the data obtained, for the purpose of more effective planning by local groups, bodies, agencies, or persons to meet the needs of aging person.
 - d. To plan, offer coordination and encourage or develop programs including applications for and administration of programs available through various governmental grants, which address themselves to the needs of aging persons, whether such programs are public, private, or individual.
 - e. Maintain an updated inventory of resources available to aging persons, both for purposes of planning and for individual referrals.
 - f. Provide leadership, public information, and educational opportunities in order to inform the public of the needs and problems of the aging person.
 - g. Advise local units of government on monetary needs of aging persons, including solicitation of local matching funds where indicated.
 - h. Provide information and referral services to individuals and groups in need of or seeking to provide services for aging persons.
 - i. Develop policy and procedures, including defining administrative staff's functions consistent with these Bylaws.
 - j. Establish proper accounting procedures to administer funds.
- SECTION 5. Membership:** The COA Board shall consist of not more than eleven (11) board members with individual appointments made in the following manner:
- a. The St. Joseph County Board of Commissioners shall have the power to appoint and re-appoint not more than eleven (11) board members (two Commissioners and nine COA Advisory Board members) to the COA Board.
 - b. The terms for the COA Board members will be for two (2) years with the exception of the member-at-large who will be appointed for a one (1) year term. Each year, five (5) members shall have their terms expire.

- c. Vacancies in the COA Board shall be filled by appointments of the St. Joseph County Board of Commissioners, preferably from a list recommended by the COA.
- d. All new appointees shall serve for the duration of the original term.
- e. Absenteeism of a member without cause shall be brought to the attention of the COA Board. In addition, annual attendance reports shall be made to the COA Board, and any member exceeding twenty-five (25%) absenteeism shall be recommended for removal and replacement by the COA Board to the Board of Commissioners.
- f. Members may be re-appointed to the COA Board.
- g. Terms of office begin on July 1st and end on June 30th of the appropriate year.
- h. Total membership should reflect the geographic composition of the County, with the recommendation that at least fifty percent (50%) of the members be over sixty (60) years of age.

SECTION 6. Quorum: A simple majority of appointed members shall constitute a quorum for business transactions.

SECTION 7. Officers: The COA Board shall elect from its membership a Chairperson, Vice-Chairperson, Secretary and Treasurer, and such other officers, as it deems necessary. Terms of office shall be for one year, ending June 30th.

SECTION 8. Election of Officers: Shall be held at the meeting preceding June 30th.

SECTION 9. Staff: The director of the COA shall be appointed by the Board of Commissioners following a recruitment process established by the Board of Commissioners which, shall include members of the COA Board. The directors shall report to the COA Board and the County Administrator/Controller and/or Board of Commissioners. The director shall serve as the chief administrative officer for the COA, oversee day-to-day operations, fulfill COA Board goals and plans, develop programs, prepare grants, and supervise and assign work to COA staff.

SECTION 10. Wages: The COA Board shall recommend the wage and benefits for the COA director and all other COA staff to the Board of Commissioners annually.

SECTION 11. Travel Expense: Reimbursement for travel and other expenses shall be at the rate determined as reasonable by the COA Board in conformance with budgeting limitations.

SECTION 12. Committees: The COA Board shall include three (3) standing committees whose members are appointed from within its membership. These committee appointments shall be from July 1st to June 30th. The standing committees shall be the following:

- 1) Executive Committee: Composed of the elected officers with one at-large member appointed by the COA Chairperson. The COA Chairperson shall serve as the Chairperson of the Executive Committee. Meetings shall be monthly, or as necessary.
- 2) Personnel Committee: Composed of the COA Vice-Chairperson with an additional three (3) at-large members appointed by the COA Chairperson. The COA Vice-Chairperson shall serve as Chairperson of the personnel committee. Meetings shall be as necessary.
- 3) Finance Committee: Composed of the COA Treasurer with an additional three (3) members appointed by the COA Chairperson. The COA Treasurer shall serve as Chairperson of the Finance Committee. Meetings shall be annually with additional meetings as necessary.

The COA Board shall appoint from within or outside its membership additional advisory or study committees as it deems necessary or appropriate.

The COA Director shall be an ex-officio member of all committees.

**COMMISSION ON AGING BYLAWS AMENDMENT
NUMBER OF MEETINGS PER YEAR**

Adopted October 18, 2023

SECTION 13. Meetings: Regular meetings shall be held six (6) times per year, on dates established by majority vote of the COA Board and posted within 10 days after the first meeting of the public body in each calendar or fiscal year. Notice of dates, times, and locations of meetings shall be distributed in accordance with the Open Meetings Act (“OMA”), PA 267 of 1976, MCL 15.265, et. seq. In addition, notice of such meetings may be published in the COA newsletter, and on the COA website at least three (3) days prior to the date of meetings.

Special meetings may be called by the Chairperson provided notice is posted pursuant to the OMA. In addition, electronic notice will be provided at least eighteen (18) hours in advance via publication on the COA website.

Standing committee meetings may be called at the discretion of the Committee Chairperson or by a request signed by the majority of the committee members.

All meetings of the COA Board and any committee of the COA Board shall be open to the public.

SECTION 14. Powers:

- a. The COA Board shall have the power to establish COA rules, policies, and procedures, except as they may conflict with legislative or regulatory edicts or these Bylaws.
- b. The COA Director shall have the power to act as the administration officer, including selection of agency staff, grants preparation and routine administrative procedures.
- c. The COA Director shall have the power to authorize disbursement of funds for payroll and payables, upon approval by the Finance Committee. The County Finance Department shall keep records and funds shall be issued by the St. Joseph County Treasurer and County Clerk.

SECTION 15. COA Assets: Upon the dissolution of the St. Joseph County Commission on Aging, all assets, real property, and personal property of the COA will revert back to the benefit of the St. Joseph County Board of Commissioners which is the local body of government that empowers and directs the COA.

This action of reverting aforementioned, to the St. Joseph County Board of Commissioners, is to ensure continuing services to the County’s senior citizens.

SECTION 16. Amendments to Bylaws:

**COMMISSION ON AGING BYLAWS AMENDMENT
PUBLIC PARTICIPATION AT BOARD MEETINGS
Adopted January 19, 2022**

PUBLIC PARTICIPATION AT BOARD MEETINGS

The Commission on Aging (COA) Advisory Board recognizes the value of public comment on older adult issues and the importance of allowing members of the public to express themselves on COA matters.

To permit fair and orderly public expression, the Board shall provide a period for public participation at public meetings of the Board and publish rules to govern such participation in Board meetings and in Board committee meetings.

The presiding officer of each Board meeting at which public participation is permitted shall administer the rules of the Board for its conduct.

The presiding officer shall be guided by the following rules:

- Public participation shall be permitted as indicated on the order of business, and/or at a time as determined by the presiding officer.
- Anyone with concerns related to the COA or to matters within the authority of the Board may participate during the public portion of a meeting.
- Participants must be recognized by the presiding officer and will be requested to preface their comments by an announcement of their name, address, and group affiliation, if and when appropriate.
- Each statement made by a participant shall be limited to four (4) minutes duration.
- No participant may speak more than once on the same topic unless all others who wish to speak on that topic have been heard.
- Participants shall direct all comments to the Board and not to staff or other participants.
- All statements shall be directed to the presiding officer; no person may address or question Board members individually.

The presiding officer may:

- prohibit public comments which are repetitive, or harassing;
- interrupt, warn, or terminate a participant's statement when the statement is too lengthy, personally directed, abusive, or obscene;
- request any individual to leave the meeting when that person behaves in a manner that is disruptive of the orderly conduct of the meeting;

- request the assistance of law enforcement officers in the removal of a disorderly person when that person's conduct interferes with the orderly progress of the meeting;
- call for a recess or an adjournment to another time when the lack of public decorum so interferes with the orderly conduct of the meeting as to warrant such action;
- waive these rules with the approval of the Board when necessary for the protection of privacy or the administration of the Board's business.

Tape or video recordings are permitted subject to the following conditions:

- No obstructions are created between the Board and the audience.
- No interviews are conducted in the meeting room while the Board is in session.
- No commentary, adjustment of equipment, or positioning of operators is made that would distract either the Board or members of the audience while the Board is in session.
- The person operating the recorder should contact the COA Executive Director prior to the Board meeting to review possible placement of the equipment.

St. Joseph County Building Preliminary Vapor Intrusion Investigation
650 and 652 East Main Street, Centreville, Michigan

Fishbeck is pleased to provide St. Joseph County (County) with this proposal for professional services. This proposal describes the scope of services and estimated fees to conduct a limited soil vapor investigation. The investigation objective is to evaluate potential vapor intrusion (VI) risks resulting from tetrachloroethylene (PCE) impacts reportedly detected in soil, groundwater, and/or soil vapor in close proximity to multiple occupied County buildings.

Fishbeck understands that the Site (Parcel #: 042 777 046 01) includes the County Jail (650 East Main Street) and Animal Control (652 East Main Street) in Centreville, Michigan. The County Jail building reportedly has multiple foundation types, including basements and crawl spaces; no information was provided regarding the foundation type(s) of the Animal Control building.

It is our understanding that the reported source of PCE impacts is historical dry cleaning operations near the north end of the strip mall at 660 East Main Street. It is our understanding that environmental impacts have been identified at the strip mall and the Pharmacy structure located at 658 East Main Street. Based on this information, the County is concerned about potential VI risks for occupants of the adjacent County buildings.

Fishbeck's services will be provided under our 2023 Environmental Services Indefinite Scope – Indefinite Delivery (ISID) Contract No. 00930, which serves the State of Michigan's MiDEAL program.

Scope of Services

The anticipated scope of services for the VI investigation includes development of a sampling plan, field investigation/sampling, reporting of results, and meetings as described in the following sections.

Sampling Plan Development

Prior to mobilizing to the field, Fishbeck will review available data regarding the PCE vapor source including, but not limited to, a *Baseline Environmental Assessment for 662 and 664 East Main Street, Centreville, St. Joseph County, Michigan* (Lakeshore Environmental, Inc., October 31, 2017) (2017 BEA)¹ and any analytical information the County can obtain regarding reported recent indoor air concerns at the evacuated structures located east of the County Buildings. Available information for the potentially affected County structures (i.e., building construction, access/security information, underground utility locations, etc.) will also be assessed to inform an effective sampling strategy. We will also submit a Freedom of Information Act (FOIA) request to EGLE for

additional files related to the former dry cleaning operations. NOTE: It is unlikely that the FOIA results will be available until after the proposed investigation is complete; however, any additional information will be reviewed and summarized in the investigation report and will be used to guide next steps.

Field Investigation

The approach taken for the field investigation will depend on the data review findings. If the data review indicates the presence of a potential vapor source beneath or adjacent to the site buildings, then soil vapor sampling will be performed inside/beneath the buildings (Approach A). If the existing data indicate that a potential vapor source is unlikely to be present beneath or within 100 feet of the site buildings, then sampling (groundwater and soil vapor) could alternatively be performed outside/adjacent to the buildings (Approach B). In either case, indoor air sampling will be performed during the initial site visit to provide an initial indication of potential risk to building occupants.

Project Strategy and Rationale

EGLE guidance indicates structures located within 100 feet of a PCE vapor source (in soil or groundwater) must be evaluated to determine vapor intrusion risks. Based solely on the information obtained from the 2017 BEA and reports of environmental impacts at the strip mall and pharmacy, it is unclear how far the vapor source(s) in soil and/or groundwater may extend. In the absence of additional information, groundwater samples collected adjacent to the structures would not adequately address potential vapor risks in accordance with EGLE guidance. Further, if groundwater sample results indicated PCE concentrations exceeding EGLE screening levels adjacent to or within 100 feet of the building, EGLE guidance indicates sub-slab vapor sampling is necessary to evaluate VI risks. Extensive soil and groundwater sampling would be required to define all vapor sources and demonstrate that no part of the jail building(s) is within 100 feet of a contaminant source. Conversely, sub-slab soil vapor sampling is an effective means of evaluating potential risks to occupants regardless of the location of the vapor source. This one-step sampling is the primary advantage of Approach A, resulting in a quick and definitive assessment of risk. In the absence of additional sampling data, a groundwater sampling approach (e.g., Approach B) is more likely to require multiple phases of sampling and a longer timeframe to definitively evaluate potential VI risks (i.e., the number of additional phases of investigation will depend on the findings from the first phase and may ultimately lead to the need to implement Approach A).

Scope of Work

Assuming Approach A is taken, Fishbeck anticipates performing a site walkover to assess foundation types, sumps, etc. and determine appropriate locations for sampling. We are assuming most locations will be conducive to installation of a vapor pin (a small sampling port installed in the concrete floor slab using a 5/8-inch drill bit) to collect sub-slab soil vapor samples. The objective of the vapor pins will be to provide a representative picture of the soil vapor concentrations beneath the buildings. We anticipate installing approximately 10 vapor pins in the jail building and three vapor pins in the Animal Control Building. These numbers are less than what is required per EGLE's recommended sampling density for commercial buildings; however, in the interest of assessing the immediate risk in a timely manner, we have scaled back the total number and will plan to focus on the following highest risk areas of the buildings:

1. Areas that are closest to the estimated vapor source (i.e., PCE impacts in soil and groundwater on the north end of the adjacent strip mall)
2. Areas that are most likely to be occupied
3. Areas with deeper foundations for basements/crawl spaces

The vapor pins will be left in place with a small protective cover, so they may be resampled in the future, if needed. Fishbeck will also be prepared to install up to five soil gas wells outside the buildings in the event that vapor pins are not feasible in any given area. We have also included a contingency for up to four indoor air samples which may be collected in the event that soil vapor field screening results (collected using a

photoionization detector [PID] just prior to soil vapor sample collection) for any vapor pin indicates that volatile organic compounds (VOCs) are present beneath the slab.

Following installation, vapor samples will be collected from each vapor pin and submitted to an analytical laboratory for analysis of chlorinated volatile organic compounds (CVOCs). Analytical laboratory selection will be based on availability. Field activities (i.e., vapor pin and/or soil gas well installation, and vapor sampling) will be performed in accordance with EGLE’s VI guidance document.

Reporting

Within 14 days from receipt of laboratory analytical results, a brief report will be prepared to summarize the field activities and results. The report will include a scaled site map and analytical data table with results summarized and compared to regulatory criteria. The report will also provide an interpretation of results and recommended next steps.

Meetings

This scope of services includes Fishbeck time for up to two virtual meetings with County representatives and other stakeholders to discuss the VI evaluation approach and results of the investigation.

Professional Services Fees

The proposed services will be performed for an estimated time-and-reimbursable expenses based fee of Eighteen Thousand Seven Hundred Dollars (\$18,700). A breakdown of these estimated fees is summarized as follows:

Assumptions


- Execution of the field investigation scope is dependent upon the County to provide access to the structures to assess all foundation types and install and sample vapor pins.
- If Approach A is taken, the unoccupied storage structures present on the County property are not included as part of this initial investigation.
- The scope of the investigation proposed herein may not be sufficient to evaluate all potential risks from the reported PCE impacts in soil and groundwater. Rather, this investigation is intended to identify potential *immediate* risks to the occupied County structures. Additional information regarding the vapor source, additional sampling, and communication with EGLE will likely be required to more comprehensively evaluate potential VI risks. Fishbeck will provide the County with a change order for approval prior to conducting any additional tasks required to supplement the initial investigation.
- This proposal is based on the limited information available at the time that the County reached out to Fishbeck. If additional information becomes available following County authorization that requires a significant alteration of the scope, Fishbeck will provide a change order for County approval as needed.
