Ordinance to Amend Section 39-40 of the Code of Village Ordinances

Shall the Village of Constantine adopt the attached ordinance completely prohibiting Adult-Use (recreational) marihuana establishments in the village?

Sec. 1 Amendment. Section 39-40 of the Code of Village Ordinances of the Village of Constantine is amended to read in its entirety as follows:

Section 39-40. Adult-Use Marihuana Establishments prohibited.

Marihuana establishments, as that term is defined in the Michigan Regulation and Taxation of Marihuana Act, 2018 IL 1 MCL 333.27951 et seq., are prohibited in the Village. A state operating license for such establishment shall not be issued or renewed after the effective date of this Ordinance.

Sec. 2 Effective Date.

The ordinance shall take effect 10 days after the date of the official declaration of the vote for the election at which this ordinance was presented to voters.

This proposal will allow the intermediate school district (KRESA) to continue to levy special education millage previously approved by the electors and restores millage lost as a result of the reduction required by the Headlee Amendment to the Michigan Constitution of 1963. Shall the limitation on the amount of taxes which may be assessed against all property in Kalamazoo Regional Educational Service Agency, Michigan, to provide funds for the education of students with disabilities for a period of 6 years, 2021 to 2026, inclusive, be increased by 1.5 mills (\$1.50 on each \$1,000 of taxable valuation) (1.4925 mills of the above is a renewal of millage that expired with the 2020 tax levy and .0075 mill is a restoration of millage lost as a result of the reduction required by the Headlee Amendment to the Michigan Constitution of 1963); the estimate of the revenue the intermediate school district will collect if the millage is approved and levied in 2021 is approximately \$12,533,825 from local property taxes authorized herein?

BONDING PROPOSAL**

Shall Constantine Public Schools, St. Joseph and Cass Counties, Michigan, borrow the sum of not to exceed One Million Six Hundred Sixty-Five Thousand Dollars (\$1,665,000) and issue its general obligation unlimited tax bonds therefor for the purpose of:

partially remodeling, furnishing and refurbishing, and equipping and re-equipping school buildings; acquiring, installing and equipping and re-equipping school buildings for instructional technology; erecting a maintenance/storage building; resurfacing, developing and improving the running track and tennis courts; and acquiring, developing and improving sites?

The following is for informational purposes only:

The estimated millage that will be levied for the proposed bonds in 2017, under current law, is 0.19 mill (\$0.19 on each \$1,000 of taxable valuation) for a -0- mill net increase over the prior year's levy. The maximum number of years the bonds may be outstanding, exclusive of any refunding, is thirteen (13) years. The estimated simple average annual millage anticipated to be required to retire this bond debt is 0.53 mill (\$0.53 on each \$1,000 of taxable valuation).

The school district does not expect to borrow from the State to pay debt service on the bonds. The total amount of qualified bonds currently outstanding is \$21,475,000. The total amount of qualified loans currently outstanding is \$-0-. The estimated computed millage rate may change based on changes in certain circumstances.

(Pursuant to State law, expenditure of bond proceeds must be audited, and the proceeds cannot be used for repair or maintenance costs, teacher, administrator or employee salaries, or other operating expenses.)
