PLANNING COMMISSION MEETING MINUTES

The regular monthly meeting of the St. Joseph County Planning Commission was held on Wednesday, July 30, 2025 in the MSU Extension Office, 612 East Main Street, Centreville, Michigan. Chairman Horton presiding.

Doug Pagels said when his term expires at the end of this year, he will not seek reappointment. His wife is now retired and he said he needs to eliminate some of his commitments. Members said Doug would be greatly missed. A motion was made by Lon Huffman, supported by Doug Pagels, to recommend the appointment of Richard Anderson and hope Derek can hold on until January to fill that vacancy. Motion carried.
