## Alcohol Permit Special Conditions

1. ALCOHOL PERMIT – **BEER & WINE ONLY.**
2. The person renting the park shall have ultimate responsibility for the actions and conduct of their guests.
3. Persons under the age of 21 shall not be permitted to possess or consume alcoholic beverages. Anyone under the age of 21 found in possession of an alcoholic beverage will be ticketed and be subject to prosecution. The Permittee shall be responsible for making sure persons under the age of 21 are not in possession of nor consuming alcoholic beverages.
4. Alcoholic beverages must be kept within the area reserved AND is not permitted in parking lot area. Any person found outside of this area with an alcoholic beverage may be ticketed and subject to prosecution.
5. Permit does not grant or intend exclusive use of park for which permit is obtained.
6. Area usage will allow all recreational activities commonly engaged in throughout the other areas of the park to parallel this scheduled event.
7. Prior permission to post signs to direct drivers to the event location must be requested and approved. Signs may not be nailed, tacked, stapled, or screwed to trees or existing signs. Signs must be removed immediately after the conclusion of the event.
8. All trash and refuse must be deposited in receptacles provided.
9. This permit may be revoked by St. Joseph County Parks and Recreation office upon Park Ranger's request due to violations of the above conditions and/or any other County Park Rules and Regulations and/or Michigan State Laws.
10. \$100.00 fee
11. Provide proof of liability insurance listing St. Joseph County as an additional insured for no less than \$1m for the day of the event.
